



**Hourly
2026 Wellbeing Requirements
for 2027 Incentive Payment**



To earn your January 2027 incentives, you must complete the following activities:

Choice and Basic PPO plan members:

You and your covered spouse can earn \$500 each by completing the following wellness activities by 9/30/2026 for a payout in January 2027. Incentive will be deposited in your Health Saving Account (HSA) and counted toward your annual contribution maximum.

PPO plan members:

You and your covered spouse can earn \$100 each by completing the following wellness activities by 9/30/2026 for a payout in January 2027. Incentive will be deposited in your paycheck as taxable income.

How to Earn the Well-Visit Incentive (For both Choice Basic PPO and PPO Plan Members):

1. Complete the online Health Risk Assessment (HRA) located on the Kapnick Strive Portal
 - a. www.kapnickstrive.com/henniges
2. Submit a completed Well-Visit Form (PCP Form)
 - Schedule and complete your physical with your PCP before 9/30/2026. You will need to take your Well-Visit form to your PCP and have the PCP provide results for all the listed items. Physicals must be completed between 10/1/2025 and 9/30/2026.
 - Submit a completed Well-Visit form by 9/30/2026
 - Well-Visit form can be uploaded on your portal homepage or faxed to 888-975-5086
 - Well-Visit form can be found on the home page of your wellness portal or in your Health Hub

3. Meet Well-Visit Incentive Criteria
 - 0-2 Health Risks are Incentive Eligible
 - 3-5 Health Risks must complete Well-Visit Reasonable Alternative Standard (RAS) Health Coaching Calls

Well-Visit RAS Health Coaching

Employees and spouses who have three (3) or more health risks can earn their well-visit incentive by completing six (6) telephonic RAS Health Coaching Calls with a Kapnick Strive Health Coach

- Deadline to Enroll in RAS is 10/15/2026
- RAS Health Coaching must be completed by 11/30/2026

If you choose not to complete all of the requirements, a monthly surcharge will apply for the employee and spouse who fails to complete all three of the requirements.

- Screening Surcharge: \$5.66 per paycheck for employee + \$5.66 per paycheck for spouse is charged for paychecks January-December 2027

Employees hired after 3/1/2026 do not have to complete the health assessment or submit a well-visit form during their first year on the plan and no surcharge will apply. Employees hired after 3/1/2026 who complete the two wellness activities will receive the incentive.

Hourly Tobacco 2026 Wellbeing Requirements



Tobacco Surcharge

Employees enrolled in Henniges medical plan who are self-reported tobacco users in BenXpress will pay a \$600 annual tobacco surcharge. You will be considered a tobacco user if you have used any of the following tobacco products in the last 3 months (12 month for new hires): cigarettes, cigars, chewing tobacco, e-cigarette, pipes, hookah, snuff, etc. **The tobacco surcharge applies ONLY to employees NOT SPOUSES.**

Tobacco Surcharge:

- Hourly: \$11.32 per paycheck (\$600 annually).

The \$600 annual tobacco surcharge will be prorated and deducted from paychecks starting January 2026. Tobacco users who complete the Tobacco RAS Health Coaching by 9/30/2026, will get a complete refund of the tobacco surcharge that was charged once the Tobacco RAS Health Coaching is completed.

Tobacco RAS Health Coaching

Employees who self-report as a tobacco user can have the tobacco surcharge refunded by completing six (6) telephonic Tobacco RAS Health Coaching Calls with a Kapnick Strive Health Coach.

- Tobacco RAS Health Coaching must be completed by 9/30/2026

The 2026 Tobacco surcharge will not apply to employees hired after 3/1/2026 for the remainder of the year. All employees enrolled in the Henniges Medical plan will need to re-attest their tobacco user status every year.

Tobacco Surcharge

Surcharge	Completion Date	Deductions Start
\$600 / year Surcharge will be refunded if program is completed by 09/30/2026.	9/30/2026 Tobacco RAS Health Coaching takes 6 weeks to complete.	January 2026 Surcharge will be prorated and deducted from paychecks starting in January.
